I understand that during the trip I and my dependent family members will have the opportunity to participate in optional activities, shopping, excursions and side trips as well as the intended activity of attending the Spruce Meadows Masters Tournament as a spectator, "*Trip*". I freely accept and assume all risks, dangers and hazards associated with my *Trip* and the events that I and my dependent family members will be participating in. I accept the possibility of personal injury, death, property damage and loss resulting from the use of services, products, accommodations, activities, side trips including the risk of negligence on the part of any service *Suppliers* and I and my dependent family members understand that *ESC hosts* shall not be responsible for any personal injury, death, property damage, loss, expense, accident, delay or inconvenience arising out of or relating to my *Trip* or my participation in any activities.

- \* Any defect in or failure of any transportation, equipment, instrumentality, service, product or accommodation which is owned, operated, furnished or otherwise used by any of the
- \* Any wrongful, negligent,or unauthorized act or omission on the part of any other person or entity not under the direct control of the *Releasees*
- \* Any negligence, breach of contract or breach of any duty of care on the part of the Releasees, or
- \* Any cause, condition or event whatsoever beyond the direct control of the Releasees
- **2.** TO HOLD HARMLESS AND INDEMNIFY THE *RELEASEES* from any and all liability for any damage to property of , or personal injury to, any third party resulting from my acts or omissions during my trip;
- **3.** This agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns, and representatives in the event of my death or incapacity;
